**RE: SCHOOL BOARD ELECTION – OCTOBER 18, 2021**

Thank you for your interest in the upcoming School Board Election.

The following information and attachments are provided for your convenience:

- Form 4: Nomination Paper and Candidate's Acceptance:
- Candidates address is the legal land description/residential address and postal code.
- A minimum of 5 signatures of electors eligible to vote is required. Only electors who are a resident of the Ward/Electoral Subdivision on the date of signing the nomination for which the candidate is being nominated may sign the nomination of the candidate.
- The candidate may appoint an official agent.
- The candidate's name must be printed as it should appear on the ballot.
- The nomination paper must be signed by the candidate and be sworn or affirmed before the Returning Officer or a Commissioner for Oaths.
- A nomination paper faxed or electronically submitted will not be accepted.
- The nomination paper will be accepted up to 12:00 noon on September 20, 2021. A deposit of \$50 in cash, certified cheque, money order or credit card must accompany the nomination filed. (A nomination paper will not be accepted without the deposit).
- Form 5 – Candidate Information – please complete and return with Form 4.
- Form 27 – Registration of a third party – please complete and return with Form 4.
- Anyone can file the nomination paper during business hours at any one of the following locations:

  - Onoway Elementary School, 5108 – Lac Ste. Anne Trail North, Onoway, AB

Election day is October 18, 2021.

- Notice of Nomination day, Election Day, and voter identification will be advertised in the local newspapers and on the Northern Gateway website. <https://www.ngps.ca/>
- Voter Identification and Eligibility: Section 53 now includes a requirement for a person to provide proof of identity and current residence in order to vote. The identification requirement sets a uniform standard of one piece of picture identification or one piece of identification authorized by the Chief Electoral Officer under the Election Act. The kinds of elector identification valid for proving eligibility to vote is attached.

- Candidates’ Scrutineer – shall make a statement in the prescribed form (Form 16 attached). Form 16 is to be presented to the presiding deputy returning officer at the applicable polling station. Photocopying of the form is permissible. The presiding deputy returning officer will designate a location within the voting station where the scrutineer may observe the election procedure.

\*Please note the difference between an official agent and the candidates' scrutineer. The agent is the official contact person for the candidate and the scrutineer only observes the vote count. The duties of an official agent are those assigned to the official agent by the candidate.

Form 11 – Enumerator, Candidate or Official Agent Proof of Identification for Section 52 Access. Please note Form 11 requires the signature of the Returning Officer or Deputy Returning Officer.

Form 12 – Campaign Worker Proof of Identification. Please note Form 12 requires the signature of both the campaign worker & candidate.

It is not the responsibility of the Returning Officer to decide on the validity of information contained in the nomination paper. If a nomination is not completed in its entirety, the returning officer shall not accept it for filing.
