- The outcomes from the Public Library Service for Indigenous Communities Symposium.
- About the partnerships and relationships being created, nurtured and sustained through this program, and how to initiate them.

Another session attended was: "The Power of Partnerships in Bridging the Digital Divide".

Digital literacy skills are increasingly critical in society whether for work, school, leisure

activities, or social connectedness. However, residents of rural areas often do not participate fully in the digital economy, due to lack of access or skills training. Since 2016, Parkland County Libraries have partnered with several community groups, including municipal staff at Parkland County, on enhancing digital literacy skills in the community through collaborative programs and services. Several new initiatives have emergence from these partnerships including: the WiFi Hotspots Lending Program, STEAM (Science, Technology, Engineering, Arts, Math) Take-Home Kits for kits, and innovative programs for children and adults.
