Google Classroom Hardware Demo:

NGPS presented this hardware at ATLE convergence summit in Calgary this last November. Also asked to participate on provincial panel on classroom redesign.

NGPS tech has been asked to be participant on another panel at the ATLE JTC Spring Symposium.

VOIP Phone

What is VOIP?

A VOIP phone is a hardware – or software – based telephone designed to use voice over IP (VOIP) technology to send and receive phone calls over an IP network.

Currently all schools and office combined spend \$126,494 yearly on Telus bills for phone services.

The VOIP project requires an initial investment of \$117,583, this initial investment saves NGPS 64% yearly on all future yearly phone bills across NGPS.

To minimize the risk to NGPS – the tech dept will be doing a 90 days pilot at Pat Hardy Primary School, Hilltop High School, Rich Valley School, Onoway Elementary School and Hillside High School.

NGPS Hosting ATLE Zone Event

NGPS tech now has representation on the ATLE Board and as such we are attempting to leverage that membership to the benefit of NGPS when possible.

ATLE conference moved to Red Deer.

On March 1st, NGPS will be hosting a remote event. The ATLE Zone directors are planning the online event on information governance and digital student records to support collaboration on implementation of digital student records.

Other Work and Changes

Over Easter Break NGPS tech will be working with CANARIE to prioritize NGPS traffic to the data centers and universities in Eastern Canada.

Powerschool Dossier – January mark submission, found hiccup in prereqs but all went very well. Upcoming Dossier and Powerschool training. Dossier allows NGPS to analyze our data better, for benefit of our schools and students.

Employment Standards Variance:

NGPS will be asking to be put on the list for the variance regarding the Three-hour pay minimum.

Employers may apply for a variance to provide less than the minimum standard requirement of three hours' pay when calling in an employee.

Basic rules:

- The Employment Standards Code states that employees must be paid for a minimum of three hours if they're asked to go to work or attend training, even if it's for a period of less than three hours, unless the employee is unable to continue working.
- An employer may apply for a variance to this rule to pay no less than 30 minutes but no more than 2.5 hours.
- The Director of Employment Standards issues variances at their discretion.
- A Director's Variance may be amended or revoked at any time.
- Variances (formerly permits) issued before January 1st, 2019 expire on January 1st, 2019 or on the stated expiry date, whichever occurs first.

Work site health and safety committees:

NGPS is ready to send in their variance application to see approval for one health and safety committee instead of the one committee for every 20 or more workers at a work site.
