Amber Gosselin, Coalition for Accessible Child Care

Amber Gosselin, presented on "Northern Gateway Coalition for Accessible Childcare" – Driving innovative and family-friendly public policy solutions."

Amber Gosselin from the Coalition for Accessible Child Care spoke to trustees about transportation issues faced by working families who live rurally. On behalf of parents and the Coalition, Ms. Gosselin shared her concern with rural busing service citing that many parents cannot be at home to receive their children after school and that school bus transportation to care providers and day homes is necessary. Ms. Gosselin asked the Board to consider policies and administrative



procedures that support working families with flexible and accessible bus service that allows children in out-of-school care to be transported to their day care provider after school. NGPS Superintendent Kevin Andrea, thanked Ms. Gosselin for her feedback and assured her that transportation needs are the subject of significant and ongoing discussion for the division, sharing the number of variables that factor into the transportation model including a lack of funding for this type of service and the overall complexity of rural school bus transportation.

Presentation was completed at 5:26 p.m. and Amber Gosselin left the meeting.

- Transportation will be launching their new webpage soon.
- It will have a GPS component where parents can track their child's bus location.
- Testing of the parent webpage is in progress.
- Parents will be able to tell if their child is eligible for transportation.
- School Cash will soon be available for parents to pay their transportation fee online.

Whitecourt Re-design:

- still some areas and communication issues to be worked out.
- Transportation staff are developing bus passes now
- Scan cards program will warn when student gets on the wrong bus or off at the wrong stop. (Scan cards not available at this time).



Questions regarding Gosselin Presentation:

- Parents are frustrated they cannot be truthful about where they live.
- parent drives their child to school, bus drives student to their day home after school
- Parent feels they will be discriminated against because bus not taking student to their home address.
- What do we do when we become aware of parents not providing a correct home address/giving their day home provided as their home address for the pm drop off?

Larger discussion to take place at the June 11th, 2019 Board Meeting.

MELT Update:

- Sept 2019 every bus driver needs to qualify
- Some previous bus drivers will be grandfathered.
- Some Boards are supporting increased costs to contractors/some are not.
- All have increased costs for training.
- 18 drivers in Northern Gateway will need MELT training.


