Minister LaGrange, Deputy Minister Curtis Clark and Assistant Deputy, Gene Williams were in attendance at the meeting. Minister LaGrange spoke to:

- wanting open lines of communication with Boards.
- wanting all to work together.
- empowering School Boards by giving us the tools we need.
- The Minister spoke to key points:

The first was in the Education Act and the naming of School Divisions. She stated it was a logistical piece to standardize names. In order for Public Boards to use the work Public all 41 Boards would have to agree.

The second was funding. Is there a better way to fund education and are the grants appropriate? There is a review in progress, including ASBA, CASS, and ASBOA. The report will go to the Minister in January, 2020, and will be part of the Budget 2020 and be implemented September, 2020.



Gene Williams gave the Alberta Education Assurance presentation (included in the Superintendent Report). They are willing to discuss all grants and programs within education.

Board Chairs shared comments on the MacKinnon Report. The ASBA Board asked for reflections on their Advocacy work. Comments included the MacKinnon Report: real numbers and what are they, small schools – M&O and Transportation. Grassroots democracy and local representation.


