NGPS Voluntary Contribution to IT – Dominica Presentation:

The IT for Dominica Foundation is a volunteer organization who, for over seventeen years, has partnered with public entities in Canada and the Commonwealth of Dominica in the interest of providing contemporary education to students and teachers in Dominica. Over this time, IT for Dominica has provided professional development, technology resources, technicians, and professional and technical expertise.

Jason Yaremchuk, the Director of Information Technology from NGPS, along with other IT volunteers, were part of a two week volunteer program to work with the Dominican Ministry of Education to deliver and install learning technologies to 23 schools, within 10 days.



#### What the volunteers did to help:

- Fundraising initiative started by Rotary Clubs in Lethbridge and Portsmouth
  - 200 new Ubiquiti Aps and 23 Cloud Key Controllers
  - 4 40 new Epson projectors and a few spare bulbs
  - **♣** 25 weather-proof Pelican cases
  - **4** 80 110/220V power bars
- 1760 Chromebooks, donated from various school divisions across AB
- 80 HP switches, donated by Edmonton Public School Division
- 6,144 Students in Dominica We provided technology for 2,701 students
- Of the 546 Primary school teachers 252 now have access to learning technologies in their classroom.


