B. APPOINTMENTS AND DELEGATIONS

Rhett Czaban, Director of Transportation gave a departmental update to the Trustees:

- Start-up has been challenging due to reworked routes in Whitecourt and the implementation of new walk distances. Routes in Sangudo and Rich Valley have also been reworked.
- Still experiencing a driver shortage and challenges with spare drivers who are not familiar with routes.
- Attended a townhall meeting with the Minister in attendance. Addressed driver shortage, overcoming training challenges, and improvement to interdepartmental collaboration. Director Czaban submitted a suggestion that provincial funding be provided to increase the minimum wage for bus drivers to \$25/hour. This would eliminate the driver shortage and recognize bus drivers for their important role in the education of our children.
- School bus evacuation training: The services of Safety on Board have been contracted to deliver a ridership program for kindergarten to grade 6/7 students. The program is excellent and has been well received.

Questions and comments from Trustees addressed by administration:

- Possible impact on the budget from an increase in minimum wage and advocacy work to receive funding.
- Question about when the last time transportation areas were reviewed.
- Transportation department staff were commended for their work on a largely successful start and dealing with several challenges.
