Fox Creek School plans for International Excursion to Spain

Fox Creek School is excited to offer students an opportunity to learn abroad in Spain and Andalusia during the Spring/Easter Break of 2026, following approval from the Board at the December 17 meeting. Students wll travel to Barcelona, Madrid, Seville and Andalusia during the Spring/Easter Break of 2026. Principal Ian Baxter shared the trip itinerary with the Board, detailing the educational value students gain from travelling overseas, including global awareness and citizenship, personal responsibility, awareness of history and current events and acceptance of others.

Athens, Florence, and Rome with Onoway Jr/Sr High School (OJSH)

OJSH teacher, Steffen Missfeldt, is excited for the school's next international excursion, which will see students travel to the Adriatic, "a region rich in history, from the time of the Greek Empire to the Romans, to the start of World War I, followed by the Soviet occupation after World War II, to today where the region has become a favourite destination of European vacationers." Students will meet learner outcomes from various programs of studies, explore and take part in cultural activities to highlight points in history, and learn more about themselves and the world around them as they explore Athens, Florence and Rome.
