All sums borrowed from the Bank shall, with interest thereon, be a charge upon the whole of the revenues of the Corporation for the current year and for any preceding years as and when such revenues are received and the SUPERINTENDENT AND SECRETARY-TREASURER is/are hereby authorized to sign on behalf of the Corporation and to furnish to the Bank an Agreement or Agreements under the Seal of the Corporation charging the said revenues of the Corporation with repayment of all sums borrowed from the Bank and interest thereon.				
6. The SUPERINTENDENT AND SECRETARY-TREASURER is/are hereby authorized and directed to apply in payment of all sums borrowed from the Bank, with interest thereon, all the monies hereafter collected or received on account or realized in respect of the taxes levied for the current year and for any preceding years and all the monies collected or received from any other source.
