2026 – 29 Three-Year Capital Plan

NGPS Facilities Director Randy Lovich reported on updates to the 2026-29 Three-Year Capital Plan including adjustments to enrolment numbers and school utilization rates where applicable. There are no changes to capital priorities.

The <u>2026-29 Three-Year Capital Plan</u> was approved by the Board as presented.

2025-26 Board Directed School Fees

NGPS Superintendent Bird made recommendation to the Board to keep 2025-26 School Fees the same as the 2024-25 school year:

- Transportation Fees for Grant Ineligible Students no change
- Tuition Fees for Non-Alberta Students no change
- Technology Access/Maintenance Fees no change

Bird reported that while there is a cost to the Division to support students and families by not increasing School Fees, NGPS "wants to be mindful of the economic times we are in, and do what we can to help mitigate some of those challenges."

Bird explained that choosing to not increase these School Fees for families means NGPS must absorb the increasing costs of these services. School bus transportation service continues to be a challenge for rural school divisions province-wide, with many school boards charging additional fees to families for both regular and supplemental bus service. Superintendent Bird emphasized the "very real benefit" NGPS offers families in providing regular bus service to students at no cost and in keeping the cost for supplemental services as low as it can be.

The Board approved the 2025-26 Transportation Fees for Grant Ineligible Students, Tuition Fees for Non-Alberta Students, and Technology Access/Maintenance Fees as recommended.

New Transportation Walk Distance for K-6 Students

Effective September 1, 2025, the walk distances for students in Kindergarten through Grade 6 who ride school buses will increase from 1.0 km to 1.6 km as per the proposed new Alberta Government regulations. There is no change to the 2.0 km walk distance for students in Grades 7 to 12.

This means, that K-6 students who live 1.6 km or more from their designated school building will continue to be funded for school bus transportation to and from school. However, students in K-6 who live less than 1.6 km from their school will now have to apply for busing (if needed).

Students in K-6 who will no longer be funded for transportation under the new ride limit will be informed of the changes via school councils and NGPS Transportation. Current Bus Fees can be viewed at ngps.ca.
